Visa Legal Sponsor Register Fees

Tier 4 Sponsorship Register Applications:

- 1 – 50 students £2,400
- 50 – 100 students £3,600
- 100 + students £4,500

Tier 2 Sponsorship Register Applications:

- 1 – 10 employees £2,400
- 10 – 50 employees £3,600
- 50+ employees £4,500

In larger institutions with more than 2 sites we will negotiate a higher rate depending on the time demand to complete the work.

These prices include the three stages in compliance work for sponsors:

- The first stage is to audit a sample of the employee files in order identify and resolve any current non-compliance issues including any current or past breaches by the sponsor.
- Secondly we help to put in place procedures, which satisfy the UK Borders Agency and assist the Prospective Sponsors to apply for a licence or if the application is refused advise the rectification process.
- Thirdly, when all of the procedures are in place, we will assist the sponsor to submit his online application and forward the relevant documents to UKBA.
